## Food service options for schools

Many WA schools provide a canteen/food service for their students. School canteens have a special role to play in supporting the education, health and well-being of the students and school communities they service.

The Western Australian School Canteen Association Inc. (WASCA) assists schools of all education systems and community groups to establish and maintain healthy, profitable food services. WASCA provides menu advice, resources and training to support the day-to-day operation of food services and the implementation of the *Healthy Food and Drink* policy. Food and drinks supplied through the school canteen/food service must comply with the Department of Education's *Healthy Food and Drink* policy and can only be established and operated through one of the following options.

Options	How does it work?	Who do I contact for advice?
Parents & Citizens' (P&C) Association Parents & Friends' (P&F)	Under the <i>School Education Act 1999</i> and <i>School Education Regulations 2000</i> , and with the Principal's written permission, a P&C/P&F Association may use the facilities of the school to operate a food service. They must be formally registered as a corporate body and as a business. Appropriate insurances and registrations must be obtained	Western Australian Council of State School Organisation Inc. Incorporated school council/ board	A school council/board may apply to become incorporated to undertake additional functions, such as managing or operating a canteen facility at the school	Department of Education Policy and Governance (08) 9264 4680 School Councils Policy and Procedures Information Package for Incorporated Councils
Management contract (Contract for Service)	This is a Contract for Service that falls under the State Supply Commission Policies. Licensing agreement (Deed of Licence)	Under this option the canteen premises is licensed to a contractor for the purpose of running a canteen. Contracted services can range from a full canteen operation (source food, menu plan, prepare and sell food) to canteen service (prepare and serve food). The contractor runs this as a business and pays a fixed rent or rent as a percentage of turnover. All fees received for the hire out of school facilities through a Deed of Licence must be received into the School's bank account under the expenses code 'C1790 Deed of Licence'.
