Equipping parents and teachers with a good understanding of the future workforce environment also helps students as they select subjects and vocational education training pathways.

State Councillors gave feedback on how parents could be better resourced and educated to support their child's career development choices; and were pleased to see the strong emphasis on the important role parents play in their child's career development.

A vital part of the initiative are the information sessions for parents, carers, employers and community members. Due to COVID-19 restrictions these have been postponed; WACSSO will share further information when restrictions are lifted.
