
## Crown Perth Emergency Procedures

Always dial 000 in the event of a lifethreatening emergency, but it is important to note that the direct emergency telephone number for any emergency at Crown is 9362 7000 (7000 from any internal telephone). If you require medical attention during your visit, please contact a Crown staff member who will contact the Crown Perth Medic Team.


Crown Perth has an Emergency Warning and Inter-Communications System in place. When the ALERT signal is sounding (an audible and continuous 'Beep...Beep'), you must follow all the directions given by Crown staff or emergency services.

When the EVACUATION signal is sounding (an audible and continuous 'Whoop...Whoop... Whoop'), you must immediately leave the building via the nearest safety exit, follow all directions and go to the assigned assembly area number 7 (car park 6). Please remain there until advised if it safe to return.

#### **Guest Speaker**

#### Hon Dr Tony Buti BPE DipEd MIR LLB DPhil MLA Minister for Education; Aboriginal Affairs; Citizenship and Multicultural Interests

The Hon. Dr Tony Buti is Western Australia's Minister for Education; Aboriginal Affairs; Citizenship and Multicultural Interests. He has been a Minister for the WA Labor Government since March 2021 and was elected the Member for Armadale on 2 October 2010. Dr Buti has worked as a high school teacher, lawyer, AFL player agent and legal academic. Dr Buti has published a number of books, most recently Alkira, a book named after his daughter that challenges us to rethink how we approach disability to move toward a more just and inclusive society. He has three adult children and in the early mornings can often be spotted jogging through the Kelmscott Hills or near Parliament.

Prior to becoming a Minister, Dr Buti was Chairman of the Western Australian Legislative Assembly Public Accounts Committee, and while in opposition, he was Deputy Chair of the Community Development and Justice Standing Committee.

#### **Director General - Department of Education**

Lisa was appointed as the Director General of the Department of Education in January 2018. Lisa is a widely respected leader in education with a clear focus on progress and achievement for all students. She is a powerful voice and advocate of reform and reconciliation and is highly committed to student outcomes, connected communities and effective leadership in schools.

Lisa has held a variety of roles ranging from psychologist, specialising in child mental health, through to executive leadership. She started her career in the public sector as an Intelligence Officer in the British Army, followed by long term appointments as the Chief Executive Officer of the Australian Institute for Teaching and School Leadership, based in Melbourne and the Deputy Secretary of Education in New Zealand. Lisa has a degree in psychology and served as a Board Director on The Foundation for Young Australians. In 2021 Lisa was awarded the ACEL WA Pre-eminent Educational Leader Award.

Joshua Patrick Northam Senior High School



#### **Keynote Presentation - Helping Children Thrive**

Dr Helen Street, Founder and Chair, The Positive Schools Initiative

As parents, we all want our children to thrive in life. We want them to experience wellbeing, to feel well and to do well – at home and at school. But what does 'doing and being well' actually mean in terms of day-to-day life? Moreover, how can we best support our children in achieving these lofty aims?

Certainly, the vast literature available on 'successful parenting', 'school-based wellbeing initiatives' and the 'pursuit of happiness' can leave the most determined of us confused and overwhelmed.

In this talk Helen will explore what it means to grow up successful and well in 2023. In so doing, she will introduce ideas and practical strategies to support a sense of 'belonging' and 'learning engagement' as core pillars of living well at home and learning well at school.

When we understand how to help our children connect well to the contexts of their lives, we understand how best to help them experience lifelong wellbeing and success.

Dr Helen Street is an internationally acclaimed expert in supporting wellbeing, an educational consultant and an applied social psychologist. She is the founder of Positive Schools and Contextual Wellbeing, a consultant to schools worldwide, a best-selling author and an honorary fellow at The University of Western Australia.



#### Keynote Presentation - Building a Future Worth Living For

Kendall Whyte, Founder and CEO at Blue Tree Project

Kendall Whyte is the Founder and CEO of Blue Tree Project, a grass-roots movement which has flourished into a charity making an impact across regional Australia.

Blue Tree Project is a WA based mental health charity with a mission to help spark difficult conversations and encourage people to speak up when battling mental health concerns. They are doing this by giving trees a 'blue lease on life' and bringing people together to create safer spaces and places to talk about mental health.

Within three years, Blue Tree Project has become a powerful platform to help promote and facilitate better understanding of mental health, provide free education seminars and create engaging community events within regional parts of Australia. By bringing people together to help create safer communities, Kendall hopes to spread the paint and spread the message that 'it's ok to not be ok'.







#### Interactive Session - Engaging Volunteers and Building Parent Participation: Initial Research Findings

Dr Megan Paull, Head of Management and Marketing, Murdoch University Dr Kath Sugars, Murdoch University

Recruiting parent volunteers is a perennial problem for P&Cs, an issue made more challenging in recent years. P&Cs are valuable contributors to public education, but their essential contributions would not be possible without the efforts and engagement of committed volunteers.

In partnership with Murdoch University, WACSSO was awarded a research grant from Volunteering WA to investigate how to engage a diverse range of parents in volunteer work. This research is investigating what works (and doesn't work) in recruiting and retaining volunteers, how we can increase volunteer participation and how we can make P&Cs more diverse and inclusive. This interactive plenary session will provide preliminary results and test findings with delegates.

Tim will be discussing the enormous impact that WA P&C trailblazers have made via Containers for Change since its inception, saving millions of containers from landfill whilst raising much needed funds for WA schools and communities.

Eva is also Project Director for the Australian Parenting and Education Support Program (PESP). Running a small business isn't easy, and when you're doing it in a volunteer capacity it can be overwhelming! This workshop aims to guide you through some of the issues our school canteens face and empower you in three key areas: running a successful business, nurturing your invaluable team, and optimising operations.

Megan Sauzier is the Chief Executive Officer of the Western Australian School Canteen Association (WASCA) and holds a Bachelor of Health Science (Nutrition) with Honours, she joined WASCA in 2006. Megan's presentation will provide guidance on optimising the operations of your canteen.

Debbie Booth commenced with WACSSO as a trainer in 2004, has run a successful small business and is currently working in finance. Debbie will focus on the canteen financial management area including reporting and budgeting, along with obligations that your P&C must address.

Lois Andrijich is the Director of Life at Work and has over 15 years' experience in Human Resources roles across for-profit and not-for-profit sectors. Lois holds a Masters in HR Management, a Certificate in Strategic Management, and undergraduate and Honours degrees in Psychology. Containers for Change works with the local community, beverage companies, recyclers and the waste industry to recycle containers, saving more than 2 billion 10¢ containers from landfill since it launched in 2020. The communication and relationship between a P&C President and the School Principal can make or break the school-P&C partnership. So, how do we nurture and grow this relationship? In this workshop, the President of WACSSO and the President of the Western Australian Primary Principals' Association (WAPPA) will host an informal discussion and Q&A session that will provide tips and advice for you to strengthen this important relationship at your school. Working together, Principals and P&Cs are better placed to achieve positive outcomes for students and families.

Pania Turner was elected President of WACSSO in 2019 and has been a WACSSO State Councillor and P&C President. Over the course of her P&C experience, Pania has seen many positive relationships between P&Cs and schools that benefit the whole school community.

Niel Smith is the current President of the WA Primary Principals' Association, which has over 1100 members across the State, in close to 90% of all primary schools. Over 24 years, Niel has been a school leader across nine schools, spanning four education regions. In addition to this, Niel has held the positions of Consultant Principal and Principal Advisor with the Department of Education. Niel's most recent principal position was at West Greenwood PS, which he led from 2017-2020.



Do you have a P&C meeting coming up and you have lots to do prior? Or perhaps you have an event with no current support? We know what it's like to feel a little tense and it's not nice. Stress can help you to stay on your toes, but what if the stress stays because of your workload, conflict or being unable to delegate?

If your body has not been given the time to recharge, then you run a risk of burnout, a state of having used up all your energy. In this session you will learn how burnout develops and what you can do to prevent it, along with other related information.

Louise has a passion for facilitating, education and development and with over twenty-five years' experience working in training and education for notfor-profit organisations in WA and corporate companies in the UK, Louise believes learning should always be fun and memorable.

Louise enjoys facilitating through a variety of platforms and engaging with people from all walks of life and is a true believer in what we learn becomes a part of who we are. The "Aha" moment in learning and unlocking an individual's possibilities is priceless.

Louise was a P&C President for three years and understands the challenges P&C's face, especially engagement, retention and recruitment of parents.



Workshop 8: Incident Management at Schools: How P&Cs Can Help Communities Impacted by Significant Events

Sally Blackmore, Lead School Psychologist, Department of Education

When a school community is impacted by a significant incident there is a need to maximise the natural supportive mechanisms of care and connection. This is core work for P&Cs and where they can have a positive support role in incident response.

Key incident management frameworks, principles and interventions will be presented to support participants in working with school leadership to respond to critical incidents.

P&Cs are key contributors in supporting schools to provide an environment for all children to be engaged and feel safe. While the school routine runs smoothly most of the time, all school communities will experience incidents which cause disruption and have the potential to threaten the safety of its members. In preparation for this schools have incident management procedures and school leaders have accessed training to enable them to respond to a wide range of critical incidents. The purpose of incident management is to minimise disruption and have schools functioning as normally as possible, as quickly as possible.

#### **Indigo Ellis**

Indigo Ellis is a 17-year-old Noongar Nunga girl growing up on Noongar Boodjar here in Perth. From the age of 7 she embarked on a journey of singing and performing that has captivated audiences throughout Perth. Indigo has numerous accolades to her name, including two NAIDOC music awards and two WA Music (WAM) awards for her original composition titled "Home", a song she wrote at the age of 13. Beyond her musical achievements, Indigo is an Ambassador for the Valuing Children Initiative, actively raising awareness about Indigenous mental health, and lending her voice to support the Aboriginal and LGBTQI+ communities, particularly the younger generation. ## 2.1 President's Message

On behalf of WACSSO State Council and staff, I present to our membership and valued stakeholders the WACSSO Annual Report 2022-2023. This report captures WACSSO's efforts to support P&Cs as they support their schools. Strong schools have the ability to strengthen the whole community.

WACSSO believes that every student is important and that Western Australian public schools can be leaders in education. When a child or young person enrols in a Western Australian public school, they become one of the 'every student.' Precious and wonderfully unique, each student shares every student's right to learn in safe, inclusive and wellresourced schools.

Economic status, cultural identity, geography, abilities, gender identity, family structure, social capabilities and diversity, in all its contexts must not present barriers.

66 Where there are challenges, we cannot let them become insurmountable. Through a collaboration of parents and educators, and with the appropriate resources, barriers can be removed. What were challenges can become platforms that lead to growth, resilience and success.

WACSSO takes this same ethos to achieve our mission by working with P&Cs, parents and education stakeholders, creating powerful partnerships to bring about positive change. Our commitment is to every child, every young person, every student; yours, mine and ours.

WACSSO presented six submissions on behalf of our affiliates during the reporting period:

• Submission in Response to the Draft National Action Plan on Teacher Shortage



- Senate Inquiry into the National Trend of School Refusal and related matters
- Therapeutic Goods Administration Potential Reforms to the Regulation of Nicotine Vaping Products
- Senate Committee Inquiry: The Issue of Increasing Disruption in Australian Schools
- SSTUWA Review of Public Education in WA
- Senate Committee Inquiry: Assessment and support services for people with ADHD

In addition to the submissions WACSSO collaborated with a number of health and community organisations taking a stance against e-cigarettes. The 2023 Joint Statement to the WA Government: Action Needed to Address Vaping is an example of the value of collective effort.

WACSSO State Councillors also represent the parent and P&C voice on many committees. Sharing lived experience helps government understand the real needs of families. I sincerely thank the families who share their personal stories with WACSSO to inform our submissions, response to media, and voice on committees; your courage and honesty is valued and appreciated.

During the year WACSSO staff have been committed to providing quality and efficient service delivery. With over 4000 contacts to the office our goal is to support our membership with timely, accurate advice, and quality resources that enable P&C volunteers to act confidently in their roles. Furthermore, we want P&C members to enjoy their time on the P&C committee. Volunteering should be rewarding and a place where friendships and connections to the school community are nurtured.

WACSSO was excited to be a successful recipient of grant funding which will see a partnership with Volunteering WA and Murdoch University in the research project, "Volunteer engagement - building parent participation in P&Cs across Western Australia". As volunteers, we know that attracting and retaining volunteers is critical to building the capacity of our P&Cs. In December 2022, the Hon. Sue Ellery MLC announced she would be moving from the Education portfolio to Minister for Finance, Commerce, Women's Interests. Sue was the Minister for Education when I first became the President of WACSSO; I acknowledge her incredible intelligence, energy and commitment to ensuring WA's schools were places where children and young people could succeed. On behalf of WACSSO, I thank Minister Ellery for supporting P&Cs as vital members of school communities. We welcome the Hon Dr Tony Buti, BPE DipEd MIR LLB DPhil MLA Minister for Education, Aboriginal Affairs, Citizenship and Multicultural Interests, and look forward to building a strong a productive relationship with Dr Buti and his team.

WACSSO also experienced leadership change with long-standing Councillor for Perth North and WACSSO Senior Vice President Jenny Blair retiring from the organisation. All of WACSSO joins me in acknowledging Jenny's deep commitment to the education of WA's children and the vital role of families in a child's learning journey from infancy through to young adulthood and beyond. Thank you Jenny, for your service. Stepping into the Senior Vice President role is Julie Brooks, Councillor for Great Southern. Julie brings a wealth of P&C experience and already proving to be an asset to the leadership team. We also said farewell to P&C favourite WACSSO Training and Development Officer Richard Brand. Richard was the go-to resource for many of our affiliates, and the expertise behind the valuable P&C resources such as the Financial Literacy eLearning, subject matter expert webinars and our on-school site training sessions.

WACSSO also represents P&Cs on decision-making committees within the Department of Education, as well as to State and Federal Members of Parliament. ### **2022 Conference** Action Items

### AC 7/2022

That the WACSSO President write to the Hon Jason Clare MP, Federal Minister for Education, to congratulate the Labor Government on their move to open the National Chaplaincy Program to give schools a choice to employ a chaplain or professionally qualified student welfare officers, and request the Minister provide further details of the change to be implemented in Australian schools.

### AC 8/2022

That the WACSSO President write to the Hon Sue Ellery MLC Minister for Education and Director General of the Department of Education and request details of how the federal announcements regarding the change to the National Chaplaincy Program will be implemented by current service providers, and when will the changes be implemented and advertised in Western Australian schools.

### AC 9/2022

That WACSSO continues to advocate on behalf of their affiliates that non-clinical student social and emotional wellbeing programs, including service providers, support, resources, and funding in public schools:

- are evidence-based;
- meet best practices; and
- employ, without bias or discrimination, qualified people with the expertise.

### AC 10/2022

That WACSSO inform all affiliate P&Cs of the Chaplaincy program funding for public schools, as per the information provided by the Federal, and State Minister for Education; and that WACSSO highlights that a qualified person of any faith or no faith can be appointed using the funding.

### AC 11/2022

That WACSSO request the Minister for Education to investigate a funding model that would allow public schools to directly employ a professional non-clinical student welfare officer on site, as an alternative to being required to contract out this essential position to a chaplaincy contractor.

#### NATIONAL SCHOOL CHAPLAINCY PROGRAM

Thank you for your letter dated 6 December 2022 to the Hon Sue Ellery MLC, former Minister for Education and Training, regarding chaplaincy services in Western Australian public schools. I am responding to you as the new Minister of Education.

I appreciate you raising these matters on behalf of the WA Council of State School Organisations Inc. I note you also wrote to Ms Lisa Rodgers, Director General, Department of Education, and I am also responding on her behalf.

The State Government continues to work with the Australian Government to consider the changes to the National School Chaplaincy Program, which has been renamed the National Student Wellbeing Program. Further information on its implementation in Western Australian schools will be provided as soon as it is available.

An election commitment of the State Government is to expand chaplaincy services to every Western Australian public school wishing to access a chaplain. Schools that voluntarily participate in a school chaplaincy program for the provision of chaplaincy services already have the choice to engage chaplains of any faith or no faith to best meet the identified needs of their students and local community.

The State Government remains committed to strengthening the social and emotional wellbeing of students and young people in our schools. Thank you for your letter of 6 December 2022 to the Hon Jason Clare MP, Minister for Education, regarding the changes to the National Schools Chaplaincy Program (Program). The Minister has asked me to reply on his behalf.

The Australian Government is committed to supporting the wellbeing of young people and school communities. The Government provides ongoing funding of \$61.43 million per year to states and territories to deliver the Program.

As you note, schools now have the option to choose either a professionally qualified chaplain or

student welfare officer under the Program. I thank you for expressing your affiliates' support of this change. The Government believes that principals and school communities are best placed to understand their students' needs. This change gives schools a choice about the services they need and the staff they hire.

Both student wellbeing officers and chaplains support the wellbeing of Australian school students

through strategies developed in consultation with the school community and educators. Their roles may include coordinating volunteering activities and support, breakfast clubs, lunch time activities, excursions, school incursions, and parent/carer workshops. Participation in the program remains voluntary for schools and students and over 3,000 school communities from all school sectors across Australia choose to participate each year.

With regard to your meeting request, unfortunately the Minister is unable to meet with you on this occasion.

## NATIONAL SCHOOLS CHAPLAINCY PROGRAM - NEWS UPDATE

As many affiliates will know, the topic of the National Schools Chaplaincy Program (NSCP) attracted a significant amount of attention in 2022.

At WACSSO Conference 2022, Maylands Peninsula Primary P&C raised a number of items in the Agenda session, all of which were passed by vote and which WACSSO Councillors and staff have been progressing with since that time. Specifically, WACSSO President, Pania Turner, has written to the State and Federal Education Ministers congratulating them on the review of this program and its funding, and the topic also featured on the agenda for her meetings with the State Minister.

Some of you may have seen that a new report was released earlier this year, following an independent evaluation of the program. There was an overwhelming response to the call for submissions to this evaluation, with over 10,000 received in 10 days from a range of community members. A high proportion (25%) of respondents were parents and guardians. A copy of the report can be found <u>here</u>. The highlights of the report findings are:

- there are benefits of having chaplains in schools but plans to broaden the scheme to include secular support staff are endorsed by those consulted.
- a growing number of children needed support and the NSCP had played a " valuable role in supporting student wellbeing".
- schools are increasingly playing a role in supporting student wellbeing.
- The Federal government needs to provide States and Territories with clearer guidelines regarding what constitutes proselytizing (guidance on this is not clear currently and it appears there is a lack of consistency in how this rule is applied)
- Significant differences were noted in how the NSCP had been delivered across the different jurisdictions when it came to funding, oversight, complaints processes, confidentially, and professional development making monitoring and oversight of the program difficult.
- The religious affiliation of the chaplain role was the most-contested part of the program.
- There was a risk of some students not receiving support through the program because of their gender identity or sexual orientation.
- There are concerns around ongoing funding.

WACSSO supports the announcement made last year by Federal Education Minister Jason Clare that from 2023, schools would have the choice of hiring either a chaplain or secular student wellbeing officer.

WACSSO also welcomes the new name: The National Student Wellbeing Program. We anticipate this title will be less polarizing and indicate a more inclusive program. The move away from the 'chaplain' reference, which puts a focus on the professional (chaplain), to the function provided (supporting student wellbeing) is a positive step

We encourage P&Cs to engage in open dialogue with their school about the changes to the program and ensure that relevant staff are aware that successful candidates for the role can come from either a religious or secular background, with preference given to the best person for the role within the school community.





### WACSSO Training Services 2022/23



Keeping our affiliates equipped to tackle the everyday operations of a P&C is a huge part of what WACSSO does. We deliver training on a variety of topics to affiliates throughout the state, these include face-to-face workshops and online webinars.




The WACSSO website contains over 60 P&C resources available for P&Cs, including 46 WACSSO created P&C resources.

### The Power of Communication

WACSSO shares information with our affiliates, parents and carers and education stakeholders. Delivering content through a variety of channels and platforms enables the Organisation to engage with our different audiences and maintain strong communication with our stakeholders. We decided this year to increase our channels of communication, adding LinkedIn to our set of social media accounts. We have also worked hard on increasing the frequency and relevance of content on our channels, resulting in audience growth.





### 2.4 A voice for parents in public education

### Advocacy

A significant part of our mission is providing a voice for parents and carers of public school students. State Councillors and staff are constantly working with affiliates and listening to their experiences. It is the voices of affiliates that empowers WACSSO to fearlessly advocate on their behalf on a National, State and Local level.

#### Working with Government

WACSSO maintains a strong relationship with both the Department of Education and Western Australian State Government.

The President meets regularly with the Minister for Education to discuss various education issues. This gives the President an opportunity to share the experiences of P&Cs and parents with the Minister.

The Minister is invited to meet with State Council during the year and also takes time to address P&C delegates at the Annual Conference.

The President also meets regularly with the Director General to discuss emerging issues. WACSSO is invited to consult on a number of Department of Education projects that affect parents.

### 2023 Joint Statement to the WA Government -Action needed to address Vaping

In response to the significant increase of the use of e-cigarettes among young people, the dramatic growth of the number of vape stores in Western Australia and the widespread availability of ecigarettes, WACSSO participated in sending a strong message to the WA government via a joint statement.

Joining such bodies as Cancer Council WA, Australian Council on Smoking and Health, and the Australian Medical Association, the statement called for the Government to take strong and immediate action at the state level, specifically:

- · Amend state legislation to explicitly prohibit the sale and supply of non-prescription ecigarettes, components and liquids, in order to aid enforcement.
- Prohibit advertising, promotion and sponsorship in relation to e-cigarettes, components and liquids to ensure these products cannot be promoted, whether or not they contain nicotine.
- Prohibit the use of e-cigarettes in public places where tobacco smoking is prohibited to help with the denormalisation of e-cigarette use and protect the community from second-hand and third-hand exposure to aerosols.
- Increase resourcing for compliance and enforcement measures to deter non-pharmacy retailers from unlawfully selling e-cigarettes.
- Resist the damaging influence of the tobacco and e-cigarette industries that seek to undermine the health of our community for commercial gain.





Subject: WACSSO Policy 2.2.1 Proposer: WACSSO State Council

- vii. Managing waste
- viii. Continuous resources for ongoing maintenance

## Agenda Item 4

Subject: WACSSO Policy 3 At the School Proposer: WACSSO State Council

### Preamble:

Over 800 government schools currently accommodate over 300,000 students throughout WA. With a significant infrastructure, staff, and student needs, the education system has the potential to make substantial positive concessions, with a view to minimising impact on the environment. Programs that reduce water and electricity usage and generate renewable energy can bring significant savings to schools and provide students with opportunities for active learning about practical ways to reduce the carbon footprint of schools and how that has a positive impact on the whole community.

### Motion:

That the WACSSO Policy, Section 3 At the School, be amended to include a new point 3.10 Environmental Sustainability to read:

3.10 Environmental Sustainability

WACSSO recognises the ecological footprint that schools have and encourages all schools to have programs that recognise their energy consumption and related emissions by:

- a. i. reducing waste;
  - ii. recycling and reusing;
  - iii. protecting and replenishing native flora and fauna; and,
- b. Implementing student-led sustainability projects.

## <u>Agenda Item 5</u> Subject: WACSSO Policy 5 Curriculum Proposer: WACSSO State Council

#### Preamble:

Over the last ten years, there has been a growth in the number of jobs in sustainability-focused industries (Annandale, D., Morrison saunders, A., & Duxbury, L. (2004). Regional sustainability initiatives: the growth of green jobs in Australia. Local Environment, 9(1), 81-87). Continuing the trend of creating a sustainable future will rely on research, design, and the application of innovative solutions. Incorporating learning areas that match these areas in the curriculum will deliver hands-on practical sustainability projects for Western Australian students, equipping them with essential skills, and investing in their future. The following proposed addition to the WACSSO policy encourages the inclusion of an engaging curriculum, with accompanying resources for schools to deliver a high-quality learning experience and provide specialist training when required.

#### Motion:

That the WACSSO Policy, Section 5 Curriculum, be amended to include a new point 5.11 concerning the importance of incorporating environmental sustainability issues within the curriculum to read: 5.11 Environmental Sustainability

5.11 Environmental Sustainability

WACSSO recognises the importance of climate change, and the effect it has on children, and supports a whole school planning framework for sustainability education. As a standard, the curriculum should:

- a. i. increase the knowledge, skills, and understanding of sustainability;
  - ii. focus on critical and innovative thinking and real-world problem-solving;
  - iii. engage with local conservation and sustainability projects; and
  - iv. use sustainability concepts and principles across the whole school community;
- b. provide resources for schools to deliver high-quality and engaging curriculum content; and,
- c. provide specialist training and peer support networks for teaching in schools.

### Agenda Item 6

Subject: Assessment Equality for Students Submitted by: Albany Senior High School Parents and Citizens' Incorporated (ASHS P&C)

### Preamble:

Equitable Access to Assessment Policy (Department of Education)

"The School Curriculum and Standards Authority (the Authority) is committed to all students having access to curriculum and assessment that is appropriate to their needs. The Authority recognises and supports individual students who may need assessment adjustments to allow them to demonstrate their knowledge, understandings, and skills."

ASHS P&C acknowledges that the Authority requires a robust procedure to administer special provisions during examinations, but re-evaluation for some diagnoses seems reductive and contraindicated in light of current medical and scientific knowledge.

At a P&C meeting held in June, several factors identified the inequalities faced by students with learning disabilities from a low socio-economic background or a remote or regional area that require more investigation.

• The current process used does not take into account students and families from low socio-economic areas who do not have the capacity to access specialist medical services.

Schools can utilise the department's school psychologists on a case-by-case basis, providing there is an appropriate service agreement in place with the school to assess psychologist services and there is adequate consulting time available in an already overwhelmed service.

• Regional & remote areas are often serviced by a visiting specialist who provides the student's diagnosis/diagnoses review. Students wishing to book in with this person frequently experience extensive waiting times, and the medical reports are routinely not able to be submitted within the timeframes required by the Authority.

Currently, there is an average waiting time to see a public specialist in Albany of approximately 12-18 months for non-urgent cases. There are currently varied waitlists for Occupational Therapists, Psychologists and Speech Pathologists in our local area between 4-18 months. The average fee structure for a review varies between \$300-\$1000+.

The information for the School's Guide to Special Provisions excerpt "Check Currency of Evidence" states: "The definition of 'current' will vary with the type of disability. For example, a hand injury during Year 11 may be recovered by Year 12, so its diagnosis will no longer be current. However, a specific learning disorder diagnosed in Year 8 or autism diagnosed as a child will still be current – but the information related to functional impact will need to be updated. All students applying for an SLD will need a functional literacy/numeracy assessment, relative to their specific SLD, conducted in Year 10 or later. Generally, for students with fine motor disorders, physical disability, health impairments, ADHD, autism spectrum disorders or mental illnesses, functional impact evidence should be collected in the year of application, or late in the previous year. It should be no more than six months old at the time of application. A template is available for health professionals to record relevant information. If the disability results from a degenerative condition, it is in the student's best interest to ensure the medical evidence is as recent as practical, i.e. usually in the year of application.

### 3.0 WACSSO Agenda Items

• Considerations by the Authority for adjustments are partially based on standardised test results which students achieved with reasonable adjustments made at a school level.

For example: Internal assessments may have allowed a student additional time and a C-pen, the Authority may not endorse the same adjustments.

### Motion:

The WACSSO President writes to the Minister for Education to request a re-examination of the "Currency of Evidence" for Equitable Access Adjustments for ATAR Course Examinations. The reasons for the re-examination of these Adjustments are threefold:

- 1. they lack equality,
- and they do not take into account the challenges experienced by students from regional/remote areas and low socioeconomic backgrounds in accessing the services and funds needed for the review of existing diagnoses.
- Onus is placed on schools to have provided adequate accommodations and documentation of these accommodations when currently there is inadequate resourcing for students with learning disabilities.

## Agenda Item 7

Subject: CCTV in Schools Submitted by: Norseman District High School P&C Association Incorporated

### Preamble:

The provision of Closed-Circuit Television (CCTV) cameras is currently the responsibility of each individual school. The result of individual schools funding their own CCTV devices is an inconsistent approach and, in many cases, no CCTV being installed due to budget constraints.

Where schools have chosen to invest in installing CCTV cameras, they are doing so by using funds that have been diverted away from projects that would otherwise be focused on teaching, learning and the students. Where CCTV cameras are absent or of poor quality, many schools are experiencing illegal behaviour on their grounds (namely breaking and entering and vandalism). This activity is distressing for the school community. In addition, in schools where CCTV cameras are not in place, insurance companies refuse to provide cover when incidents occur.

The ability for schools to be safe spaces in our community would be enhanced by the standard provision of CCTV cameras across public schools in Western Australia.

### Motion:

That the WACSSO President writes to the Minister for Education to request funding for CCTV in public schools across Western Australia.


